

KHADI SCHEMES

KHADI-POLYVASTRA REBATE

Sale of Khadi (Cotton, Woolen, Silk) & Polyvasra produced in Gujarat is made through registered Khadi Institutes/Societies. For the generation of employment to the artisans and to boost the marketing of Khadi & Polyvasra produced in the State, M.D.A. (Marketing Development Assistance) is declared by KVIC and also 10% rebate is declared by the State Government from 2nd October to 31st March. Implementation of 15% M.D.A. instead of Rebate Scheme is to be made from ensuing year 2016-17.

KHADI POLYVASTRA SPINNING SPECIAL WEAVING EQUIPMENT SCHEME :

- (A) Special Spinning Assistance Rs.1/- per Hank on Hank production beyond the fixed wage is paid to the General and Scheduled Caste.
- (B) Special Spinning Assistance Rs.1.50 paise/- per Hank on Hank production beyond the fixed wage is paid to the Scheduled Tribe.
- (C) Beyond the fixed Weaving charges Special Weaving Assistance Rs.3/- per sq.mtr. and Rs.1/- is paid according to weaving equipment assistance to the Weaving artisans for General and Scheduled Caste beneficiary by the State Government.
- (D) On woven sq.mtrs. Scheduled Tribe beneficiaries are given Rs.4/- per sq.mtrs. as a special weaving assistance and Rs.1/- Weaving Equipment Assistance beyond fixed weaving wages by State Government



NEW CHARKHA/LOOM SCHEME

To inspire the new generation to work in the field of Khadi and to generate the employment, the new Charkha Loom Scheme is in operation through the registered institutes of Khadi & Village Industries Commission (Government of India) by Gujarat State Khadi & Village Industries Board. In this Scheme, 65% assistance is given by State Government and 35% contribution of Price of the Charkha/Loom is borne by the beneficiaries/institutes.

CLUSTER DEVELOPMENT SCHEME

The Khadi Polyvasra Scheme is in operation by Commissioner Cottage Industries through the institutes of Khadi & Polyvasra which are engaged in production/Sale of Khadi & Polyvasra by Gujarat State Khadi & Village Industries Board. According to the structure fixed by State Government for Cluster Development Scheme, the institutes/societies are paid the grant on account of their working by Gujarat State Khadi & Village Industries Board. New proposals for the scheme is to be conducted by District Industry Centre of the concerned district.

VILLAGE INDUSTRIES SCHEMES

EXHIBITION CUM FAIR

To boost the marketing of Khadi & Village Industries products and to generate the employment for artisans, exhibitions cum fairs are organized in the various places of the State. Efforts are made to increase the sale of Khadi & Village Industries products by organizing National Level Exhibitions with the cooperation of Khadi & Village Industries Commission.

SHORT TERM TRAINING

To generate employment in rural area of the State, monthly training is given and Rs.1000/- is given as a stipend, also training certificate is issued with training literature.

TOOL KITS TRAINING

Under the Manav Kalyan Yojana B.P.L. Trainees-beneficiaries are provided Tool kits (Equipment Assistance) within limit of Rs.5000/- according to the Trade-wise standard fixed by State Government.

PRIME MINISTER EMPLOYMENT GENERATION PROGRAMME (PMEGP)

PMEGP Scheme is implemented by Khadi & Village Industries Commission (MSME-Government of India) from the year 2008-09, this scheme is implemented through Nationalized Banks in the State. For production maximum Rs.25/- lakh and in the field of Service Rs.10/- lakh loan is sanctioned.

The standard of subsidy is categorically 15% to 35% and categorically contribution of loanee is 5% to 10%.
